CLLC CONTINUES TO COLLABORATE WITH THE CONFEDERATED SALISH AND KOOTENAI TRIBES AND BLACKFEET TRIBE TO DEVELOP CLIMATE ADAPTATION PLANS AND NOW MORE FORMALLY REFER TO THIS AS THE TRIBAL CLIMATE CHANGE NETWORK. WE ARE WORKING TO EXPAND THIS NETWORK TO INCLUDE TRIBAL COMMUNITIES FURTHER EAST IN MONTANA, AND WE ARE SHARING SOME OF OUR LESSONS LEARNED AT NATIONAL CONFERENCES FOCUSED ON CULTURALLY SENSITIVE CONSERVATION.

DURING THE PAST YEAR WE WRAPPED UP A PILOT PROJECT WITH THE NATIONAL FISH AND WILDLIFE FOUNDATION.
